GSR.....- In exercise of the power conferred by the provision to Article 309 of the Constitution and in supersession of Ganga Flood Control Commission (Group 'C' Posts Recruitment Rules 1988, except as respects things done or omitted to be done before such supersession, the President hereby makes the following rules regulating the method of recruitment to erstwhile Group 'C' post, now upgraded to Group-'B' Non-Gazetted posts as pre recommendation of 6th CPC and in accordance with DOPT's O.M.No. AB-14017/6/2009-Estt(RI dated 30.04.2010 in the Ganga Flood Control Commission, under Ministry of Water Resources, RD & GR namely:-

1. Short title and commencement.-

- These rules may be called Ministry of Water Resources, RD & GR the Ganga Flood Control Commission, Draftsman Grade-1, Group 'B' Posts Recruitment Rules, 2022. (2) They shall come into force on the date of their publication of this notification in the Official Gazette.
- 2. **Application**.- These rules shall apply to the posts specified in column 1 of the schedule annexed to these rules.
- 3. Number of post, classification, pay band and grade pay or pay scale. -The number of said post, its classification, pay band and grade pay or pay scale attached there to shall be as specified in columns '2' to '4' of the Schedule annexed to these rules.
- 4. Method of recruitment, age limit, qualifications etc. -The method of recruitment, age-limit, qualifications and other matters relating thereto shall be as specified in columns '5' to '13' of the said Schedule.
- 5. **Disqualification**.(a) Who has entered into or contracted a marriage with a person having a spouse living, or
- (b) Who, having a spouse living, has entered into or contracted a marriage with any other person shall be eligible for appointment to the service:

Provided that the Central Government may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and that there are grounds for so doing, exempt any person from the operation of this rule.

- 6. Power to relax. Where the Central Government is of the opinion that it is necessary or expedient so to do, it may, by order, for reasons to be recorded in writing relax any of the provision of these rules with respect to any class or category of persons.
- 7. Saving. Nothing in these rules shall affect reservations, relaxation of age-limit and other concessions required to be provided for the Scheduled Castes, the Schedules Tribes, Other backward Class, ex servicemen and other special categories of persons in accordance with the orders issued by the Central Government from time to time in this
