- G.S.R. 69.—In exercise of the powers conferred by the proviso to article 309 of the Constitution and in supersession of Ganga Flood Control Commission (Stenographer Grade -I) (Group 'B' post) Recruitment Rules, 1984, in so far as it relates to the post of Stenographer Grade-I in the Ganga Flood Control Commission, except as respects things done or omitted to be done me before such supersession, the President hereby makes the following rules regulating the method recruitment to the posts of Stenographer Grade -I in the Ganga Flood Control Commission the Ministry of Water Resources, River Development & Ganga Rejuvenation namely:-
- Short title and commencement. —(1) These rules may be called Ministry of Water Resources, River Development & Ganga Rejuvenation, the Ganga Flood Control Commission, Stenographer Grade -I, Group 'B' Posts Recruitment Rules, 2015,
 - (2) They shall come into force on the date of the publication of this notification in the Official Gazette.
- 2. Number of Posts, classification, pay band and grade pay or scale of pay. The number of said posts, their classification and pay band, grade pay or pay scales attached thereto, shall be as specified in columns (2) to (4) of the Schedule annexed to these rules.
- 3 Method of recruitment, age limit and qualifications, etc.—The method of recruitment, age limit, qualifications and other matters relating thereto shall be as specified in columns (5) to (13) of the aforesaid Schedule.
 - 4. Disqualification.- No person,-
 - (a) who has entered into or contracted a marriage with a person having a spouse living; or
- (b) who, having a spouse living, has entered into or contracted a marriage with any other person,

shall be eligible for appointment to the said post:

Provided that the Central Government may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and that there are other grounds for so doing, exempt any person from the operation of this rule.

5. Power to relax.— Where the Central Government is of the opinion that it is necessary or expedient so to do, it May, by order, for reasons to be recorded in writing and in consultation with the Union Public Service Commission, relax any of the provisions of these rules with respect to any class or category of persons.

6. Saving.- Nothing in these rules shall affect reservation, relaxation of age-limit, and other concessions required to be provided for the Scheduled Castes, the Scheduled Tribes, ex-servicemen and other special categories of persons in accordance with orders issued by the Central Government from time to time in this regard.

Note 1: Where juniors who have completed their qualifying or eligibility service are being considered for promotion, their senior shall also be considered, provided they are not short of the requisite qualifying or eligibility service by more than half of such qualifying or eligibility service or 2 years, whichever is less and have successfully completed their probation period for promotion to the next higher grade along with their juniors who have already completed such qualifying or eligibility service.

Note 2: For the purpose of computing minimum qualifying service for promotion, the service rendered on a regular basis by an officer prior to 1st January, 2006 or the date from which the revised pay structure based on the Sixth Central Pay Commission recommendations has been extended, shall be deemed to be service rendered in the corresponding pay or pay scale extended based on the recommendations of the Pay Commission.

Note 3: One week training in related field of duties of promotional post.

Deputation including short-term contract:

Officers under the Central Government or State Government or Union Territory or Public Sector Undertakings or Statutory Organisations or Universities and recognized Research Institutions.

(i) holding the post of Stenographer Grade 'C' or Grade-I in the PB-2, Rs.9,300-34,800 plus grade pay of Rs. 4,200 on regular basis in the parent cadre or department; or

(ii) holding the post of Stenographer Grade 'D' with 10 years regular service in the Pay Band-1 with Grade Pay of Rs. 2400.

Note 1: The departmental officers in the feeder grade who are in the direct line of promotion will not be eligible for consideration for appointment on deputation including short-term contract. Similarly, the deputationists shall not be eligible for consideration for appointment by promotion.

Note 2: Period of deputation (including short-term contract) in another ex-cadre post held immediately preceding this appointment in the same or some other organization/department of the Central Government shall ordinarily not to exceed three years.

Note 3: The maximum age-limit for appointment by deputation (including short-term contract) shall be 'not exceeding 56 years' as on the closing date of receipt of applications.

Note 4: For the purpose of appointment on deputation (including short-term contract) basis, the service rendered on a regular basis by an officer prior to 1st January, 2006 (the date from which the revised pay structure based on the Sixth Central Pay Commission recommendation has been extended) shall be deemed to be service rendered in the corresponding grade pay/pay scale extended based on the recommendations of the Pay Commission except where there has been merger of more than one pre-revised scale of pay into one grade with a common grade pay/pay scale and where this benefit will extend only for the post(s) for which that grade pay/pay scale is the normal replacement grade without an upgradation.
